

Col. Daniel served on Burke's Board of Trustees since 1999. During those 23 years of service, he was a strong advocate and compassionate leader for the individuals Burke served. In addition, Col. Daniel always focused on the needs and

challenges of employees. He supported staff, ensured they had the tools to do their job, and knew they were valued and respected.

Col. Daniel was a lifelong leader of service to his community and country. After 28 years of military service, he returned to his roots in Livingston, Texas. He was determined to spend the rest of his life bringing a kind spirit and positive influence to people around him.

"There are no large or small people," are the words of Col. Daniel's father, Howard Sr., words that influenced him on viewing people equally. After his now adult daughter, Little Marie, who was born with a developmental disability, a former Polk County judge encouraged him to serve on the Burke Board of Trustees in 1999. In 2011, he was elected chairman, which he held until his passing.

Under his leadership, Burke doubled capacity in individuals served by mental health services, expanded developmental disability services, coordinated with law enforcement in crisis management, built new facilities for services, and expanded to provide specialty services to groups such as children and military veterans.

Col. Daniel was a leader and a servant. He led by example and guided others to selfactualization through strategic thinking. His motto was, "I never meet a stranger, and everybody is somebody to me."
